The Regular City Council Meeting of the Anita City Council was held October 12, 2022 with Mayor Knutson presiding.

Mayor Knutson called the regular city council meeting to order at 6:30 pm.

Motion by Harris; second by Dorsey to approve the agenda as posted. All voted aye. Motion passed.

Motion by Littleton, second by Andrews, to approve the consent agenda removing the liquor license for Good Directions LLC dba The Redwood Steakhouse class c liquor license and adding it to the regular agenda. All voted aye. Motion passed.

Motion by Jensen, second by Andrews, to approve CAM 4 KIDS PTO Haunted Trail on October 22<sup>nd</sup>, 2022, beginning at Keystone Park with young kids from 6:30-7:30pm, and big kids/adults from 7:30-10:00pm. All voted aye. Motion passed.

Motion by Littleton, second by Dorsey, to approve liquor license for Good Directions LLC dba the Redwood Steakhouse class c liquor license. All voted aye. Motion passed.

Discussion on the redevelopment of 1003 Main Street into a 10,500 square foot general retail use. The property is zoned appropriately for the use as central business district.
