The Anita Planning & Zoning Commission met in special session/ Public hearing Wednesday, August 13<sup>th</sup>, 2025 at 6:15PM. Zoning Board members present were: Julie Pollock, Susan Retz, Megan Dorsey, Krista Young and Kim Kopp. Also present were Anita Development members, City Council members, the City Attorney various members of the public.

The Public Hearing was called to order at 6:15 pm.

Darrell Hockenberry from the Anita Development has made a written request to change in zoning district classification from R-4 mobile home park to R-2 two-family residential. Effectively repealing and replacing the R-4 mobile home park zoning district.

Mr. Hockenberry gave a brief overview of plans for the area for which this change is requested. Various questions were asked by members of the commission and the public. No verbal or written objections were received.

Motion by Pollock; second by Kopp to recommend approval of the proposed change of all existing property in the R-4 Mobile Home District to R-2 Two Family Residential District and provide recommendation in writing to the City Council. Discussion held on Resolution 2025-26 entitled "APPOINTMENT OF ANITA MUNICIPAL AIRPORT COMMISSION MEMBER". Motion by Dorsey; second by Sokol to approve Resolution 2025-26 as presented. Roll Call Vote: Huffman-aye, Jensen-aye, Andrews-aye, Sokol-aye. Resolution passed.

The council was presented with a building permit. A motion by Dorsey, seconded by Andrews to approve permit as presented. Ayes: All. Motion passed.

City Attorney, Justin Hockenberry gave the council updates on pending matters. The properties at 308 Elm Street and 211 Rosehill Avenue have changed ownership with the assistance of all interested parties. The City attorney has obtained an assignment of an outstanding Tax Sale Certificate which will allow the City to obtain clear title to 9 Sun Valley Road.

During the meeting, the council, clerk, mayor, and members of the public shared updates and voiced concerns. Issues/concerns included: underage drivers in golf carts, grass clipping on streets, nuisance properties, alley/driveway washouts and bike traffic on sidewalks.

Iowa law requires a valid driver's license to operate a golf cart on public roads.

Anita Library employees requested that parking lines be painted on the blacktop in front of the building to help space cars equally and better mark handicapped accessible stalls.

Many members of the public expressed pride and gratitude to volunteers and city employees for the recent 150th anniversary celebration activities. Drone pictures taken during Anita's Annual Steak Fry would make a welcome addition to City Hall.

City Council Members are looking for public input for town beautification. Please contact the City Clerk with your thoughts. Ideas include fixing the town sign, installing speakers on Main Street, and metal shade structures. Other suggestions are welcome!
